

**ORDINANCE MODIFYING FINES
FOR PARKING, ANIMALS, AND NUISANCES**

WHEREAS, the Town of Chalmers, Indiana, (the "Town") desires to modify the fines for various ordinances passed by the Town; and

NOW, THEREFORE, BE IT ORDAINED BY THE COUNCIL OF THE TOWN OF CHALMERS, INDIANA, THAT:

Section 1: The Town desires to delete Chapter 73, Schedule I, Paragraph (A)(3) and replace it with the following:

(3) Any person found to be violating division (A)(1) or (A)(2) above shall be guilty of a misdemeanor and, on conviction thereof, shall be fined \$50 for the first offense, \$100 for the second offense, and \$150 for each offense thereafter.

Section 2: The Town desires to delete Chapter 73, Schedule I, Paragraph (B)(2) and replace it with the following:

(2) Any person found to be violating any part of this division (B), or the owner of any vehicle parked in violation of this division (B) shall, on conviction thereof, be fined \$50 for the first offense, \$100 for the second offense, and \$150 for each offense thereafter.

Section 3: The Town desires to delete Chapter 73, Schedule II, Paragraph (D) and replace it with the following:

(D) Any person found to be violating any part of Schedule II shall be notified of the infraction, and shall be fined \$50 for the first offense, \$100 for the second offense, and \$150 for each offense thereafter.

Section 4. The Town desires to delete §91.99(B) and replace it with the following:

(B) Owners of animals impounded under §§91.01 to 91.05 or otherwise in violation thereof may be subject to a fine of \$50 for the first offense, \$100 for the second offense, and

\$150 for each offense thereafter.

Section 5. The Town desires to delete §92.99(B) and §92.99(C) and replace them with

the following:

(B) Any person in violation of §92.01 shall be arrested by the Town Marshal without process and fined \$50 for the first offense, \$100 for the second offense, and \$150 for each

offense thereafter.

(C) Every person, firm or corporation violating the terms of §92.02 shall, upon

conviction, be fined \$50 for the first offense, \$100 for the second offense, and \$150 for each

offense thereafter.

Section 6. This Ordinance shall be in full force and effect from and after its passage and

adoption.

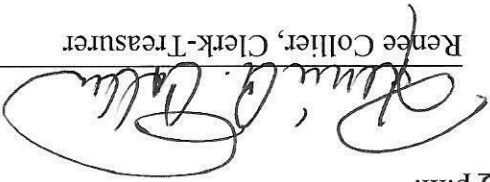

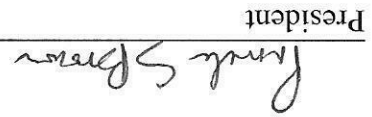
